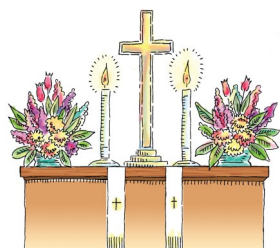
Please note the following guidelines have been put in place to make Worship in-person safe for all.

Guidelines for re-entry for worship in the Sanctuary:

- Face masks will be required in the facility at all times.
- Please maintain social/physical distance while in the facility.
- All access to the building will be through the front Sanctuary doors.
- Enter Sanctuary through the center aisle and exit through side aisles only.
- Seating will be available at every other pew (pews will be cordoned off). Ushers will assist in seating everyone.
- Families may sit together in the same pew. All other individuals are limited to three in a pew.
- We will refrain from congregational singing. Enjoy listening!
- Only restrooms located in the Narthex will be available.
- There will be hand sanitizer stations and face masks available.
- Please access outdoor areas for all personal time of greeting and socializing.
- If you are running a low fever or have been coughing, please do not attend worship.

Childcare during worship:

- Children are always welcome to worship with their parents in the sanctuary.
- Childcare will be available for those willing, during the worship time in the gym. Your child's/children's temperature will be taken using a no-touch forehead thermometer. Parents will sign a waiver, and drop-off their children at the gym door (please use the East garden entrance to the gym).

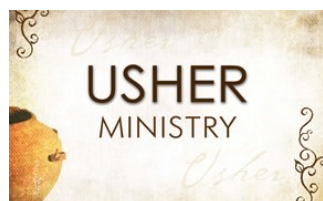
